**STORAGE AND DISPOSAL**

Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Shake bag contents into spray tank until the bag is empty. Do not dispose of undiluted chemicals on site. Puncture or shred and deliver empty packaging for appropriate disposal to an approved waste management facility. 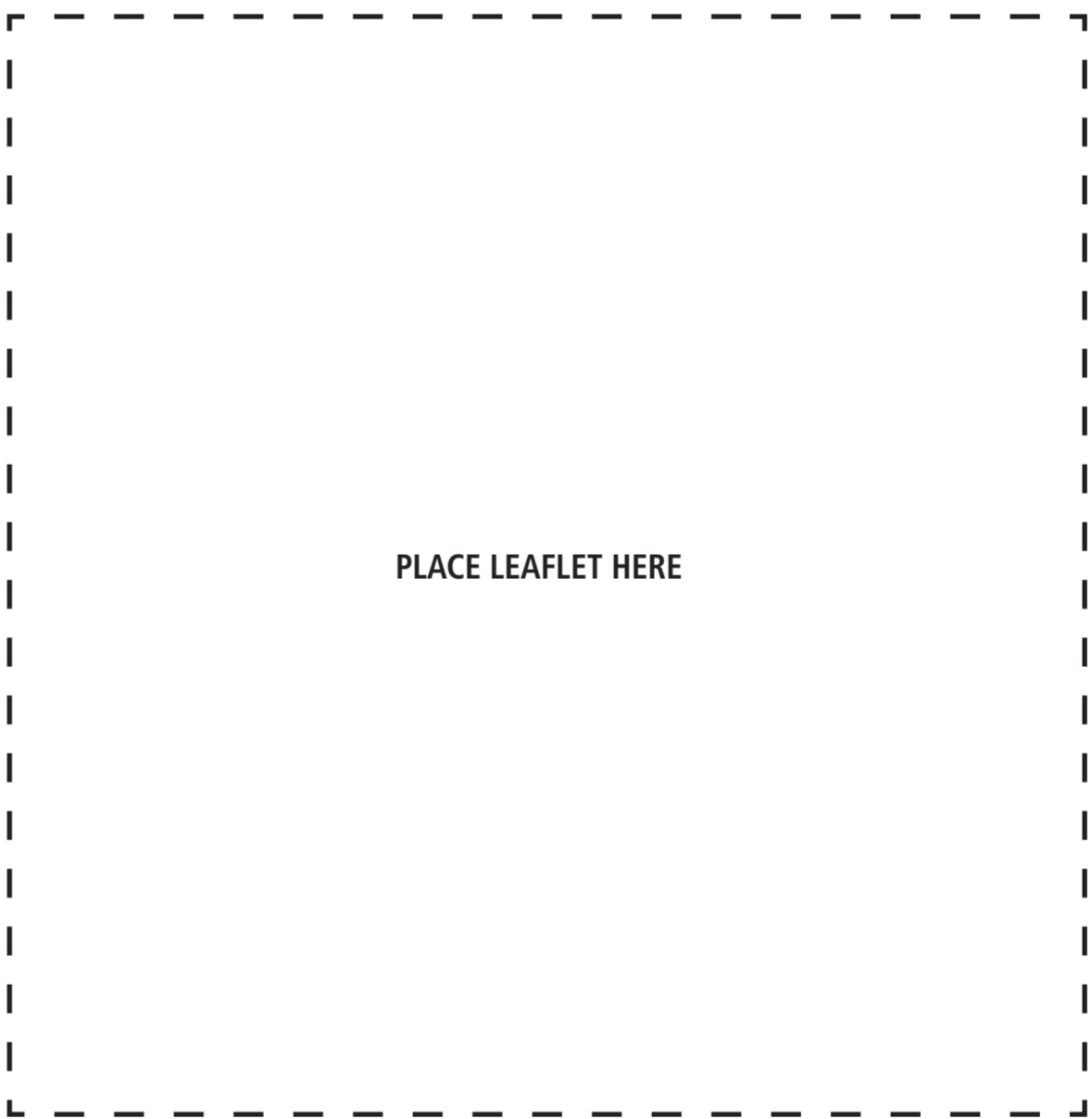
