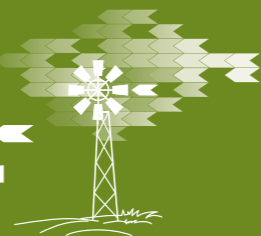

## Apparent Affray 300 HERBICIDE

### STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area away from children, animals, food, feedstuffs, seed and fertilisers. DO NOT store for prolonged periods in direct sunlight. Triple-rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.

### SAFETY DIRECTIONS

Harmful if inhaled or swallowed. Will damage the eyes. Will irritate the skin. Avoid contact with the eyes and skin. Avoid inhaling vapour. When opening the container and preparing spray or using undiluted concentrate, wear cotton overalls buttoned to the neck and wrist and a washable hat, elbow-length chemical resistant gloves and face shield or goggles. When using the prepared spray, wear cotton overalls buttoned to the neck and wrist and a washable

hat and elbow-length chemical resistant gloves. If applying by hand wear half facepiece respirator with organic vapour/gas cartridge or canister. If product on skin, immediately wash area with soap and water. If product in eyes, wash it out immediately with water. After use and before eating, drinking or smoking wash hands, arms and face thoroughly with soap and water. After each day's use, wash gloves, respirator and if rubber wash with detergent and warm water, face shield or goggles and contaminated clothing.
