# STORAGE AND DISPOSAL

**Bottle:** Store in the closed, original container in a cool, well-ventilated area as cool as possible. DO NOT store for prolonged periods in direct sunlight.

Keep from contact with fertilisers, insecticides, fungicides and seeds. Triple rinse containers before disposal. Add rinsings to the spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point.
