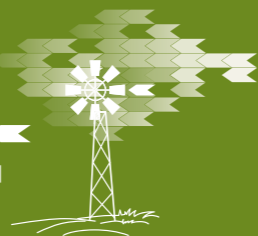

SITUATION	APPLICATION RATE/100 L	CRITICAL COMMENTS
Post emergent herbicides	0.3 – 1.0 L	Apparent Canola Oil Ester Adjuvant may be used in place of non-ionic surfactants or crop oils. Subject to spray volumes; usage rates may vary between 0.2 – 2.0 L of Apparent Canola Oil Ester Adjuvant per hectare.

GENERAL INSTRUCTIONS:

Apparent Canola Oil Ester Adjuvant is a highly penetrating spray adjuvant suitable for use with certain post emergent herbicides. It improves herbicide performance by utilising the excellent penetration effect of esterified vegetable oils in combination with the wetting and spreading characteristics of non-ionic surfactants.

Apparent Canola Oil Ester Adjuvant can be added to certain post emergent herbicides to increase efficiency. In some situations Apparent Canola Oil Ester Adjuvant may reduce selectivity. Care must be exercised when applying Apparent Canola Oil Ester Adjuvant with post emergent herbicides on sensitive crops under conditions where plants are subject to drought stress, high temperatures, and high humidity. If in doubt use precaution and trial by application to a small area before committing to a large scale application.

PRECAUTION

Read all directions for use on the Apparent Canola Oil Ester Adjuvant label and on the herbicide label. The herbicide manufacturer's directions and recommendations always take precedence over directions contained on the label.

MIXING AND SPRAYING

Follow directions on the herbicide label. Half fill spray tank with water and add the required amount of herbicide while agitating. Top up the tank with water then add the required amount of Apparent Canola Oil Ester Adjuvant and continue agitating while spraying.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT:

DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

STORAGE AND DISPOSAL

Keep out of the reach of children. Store in the closed, original container in a well-ventilated area as cool as possible. Protect from frost. DO NOT store for prolonged periods in direct sunlight. Under conditions below 0°C Apparent Canola Oil Ester Adjuvant may thicken and become cloudy. It returns to a normal clear liquid state above 0°C.

Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

SAFETY DIRECTIONS

May irritate the eyes and skin. Avoid contact with skin or eyes. Avoid inhaling vapour or spray mist. When opening the container and preparing the spray, wear overalls, rubber gloves and goggles or disposable spray shield. After each day's use, wash contaminated clothing, gloves and face shield or goggles with soap and water.
