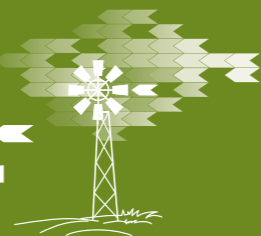

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

Returnable/Refillable containers:

Empty contents fully into application equipment. Close all valves and return to [point of supply/designated collection point/other specific collection details] for refill or storage.

SAFETY DIRECTIONS

Harmful if swallowed. Will damage eyes. Will irritate the skin. Avoid contact with the eyes and skin. When opening the container, preparing the spray and using the prepared spray, wear cotton overalls buttoned to the neck and wrist and a

washable hat, elbow-length PVC gloves and goggles. If product on skin, immediately wash area with soap and water. If product or spray, in eyes, wash it out immediately with water. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use wash gloves, goggles and contaminated clothing.
