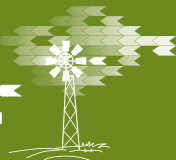

PRECAUTION: RE-ENTRY

DO NOT allow entry into treated areas until the spray has dried. When prior entry is necessary, wear chemical resistant gloves. Clothing must be laundered after each day's use.

PROTECTION OF CROPS, NATIVE AND OTHER NON-TARGET PLANTS

DO NOT plant cereal crops into the treated area for a period of 18 weeks after application of Apparent Quizalofop 200 EC Selective Herbicide.

DO NOT apply under weather conditions, or from spraying equipment that may cause spray to drift onto nearby susceptible plants/crops, cropping land or pastures.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

STORAGE AND DISPOSAL

(20 L and 200 L only): DO NOT store tank-mixes of Apparent Quizalofop 200 EC Selective Herbicide with other materials. Store in the closed original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. When storing, keep from contact with fertilisers, fungicides and seeds. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, relace cap and return clean container to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the container below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt. If the container is a returnable/refillable type, when empty, or contents no longer required, return the container to the point of purchase. This type of container remains the property of AIRR Apparent Pty Ltd.

Envirodrom 110 L Mini Bulk Returnable Container: Store the original sealed Envirodrom in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. DO NOT tamper with the Micro Matic valve or the

When opening the container, preparing spray and using the prepared spray, wear cotton overalls buttoned to the neck and wrist, a washable hat, and elbow-length PVC gloves. If product on skin, immediately wash area with soap and water. Wash hands after use. After each day's use wash gloves and contaminated clothing.
