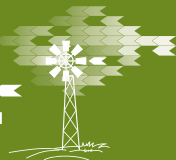

## Apparent Triadimefon 500 WG FUNGICIDE

### STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point.

If not recycling, break, crush, or puncture and bury containers at a local authority landfill. Empty packaging for appropriate disposal at an approved waste management facility. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, vegetation and roots. Empty containers and product should not be burnt.

### SAFETY DIRECTIONS

Poisonous if swallowed. May irritate the eyes and skin. DO NOT inhale dust. When preparing product for use, wear cotton overalls buttoned to the neck and wrist and a washable hat, elbow length chemical resistant gloves

and a disposable dust mask. After use and before eating, drinking or smoking wash hands, arms and face thoroughly with soap and water. After each day's use, wash gloves and contaminated clothing.

### FIRST AID

If poisoning occurs, contact a doctor or Poisons Information Centre. Phone Australia 131126. If in eyes, hold eyes open, flood with water for at least 15 minutes and see a doctor.
