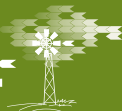

HOW TO USE

DO NOT if rain is expected within 4 hours.
DO NOT apply in windy conditions.
DO NOT apply to damaged or stressed turf.
DO NOT mow for 3 days after spray application.
DO NOT fertilise for at least 10 days before or after application.
DO NOT cover spray buffalo or kikuyu lawns – spot spray only.

Bent and Fescue Lawns	Duckweed, Fleabane, Lamb's Tongue, Mouse-eared Chickweed, Mullumbimby Couch,	Mix 85 mL per 2 L of water and spray over 10 m ² .	Mix 45 mL per 1 L water.	Respray in 10 days if necessary. SPOT SPRAY ONLY ON BUFFALO AND KIKUYU
Buffalo and Kikuyu Lawns	Nutgrass, Paspalum, Scarlet Pimpernel, Summergrass (Crab- grass), Water Couch, White Clover.	DO NOT COVER SPRAY BUFFALO OR KIKUYU LAWNS	Mix 45 mL per 1 L water.	LAWNS AS SOME DAMAGE TO LAWNS IS EXPECTED

HOW TO PREPARE:

Product can be applied with most garden sprayers. For more effective wetting, add wetting agent to final solution. Avoid using fine droplets or applying product in windy conditions as this will increase spray drift. It is important to apply the recommended spray mixture when weeds are young and actively growing, results may take time to become evident.

CAUTION: DO NOT allow spray to contact other plants that you do not want killed. DO NOT allow chemical containers or spray to get into drains, sewers, streams or ponds. DO NOT feed treated grass clippings from treated areas poultry or other animals.

STORAGE AND DISPOSAL: Store in the closed, original container in a cool, dry place out of the reach of children. Do not store in direct sunlight. Dispose of empty

container by wrapping in paper, placing in plastic bag and putting in garbage.
SAFETY DIRECTIONS: Poisonous if absorbed by skin contact or swallowed. Will irritate the eyes and skin. Avoid contact with eyes and skin. Do not inhale vapour. Repeated exposure may cause allergic disorder. When opening the container and preparing spray and using the prepared spray wear cotton overalls buttoned to the neck and wrist and a washable hat and elbow-length PVC gloves and face shield or goggles. If product in eyes, wash it out immediately with water. If product on skin, immediately wash area with soap and water. After each day's use wash gloves, face shield or goggles and contaminated clothing.
