STORAGE AND DISPOSAL

Store in a locked room or place away from children, animals, food, feed stuffs and fertilizers. Store in the closed, original container in a dry, cool well-ventilated area out of direct sunlight. DO NOT store in or expose product to wet conditions. Rough handling of product may cause breakage of water soluble bags, especially at low temperatures. DO NOT dispose of undiluted chemicals on-site. Break, crush or puncture sachets and containers and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

SMALL SPILL MANAGEMENT

Sweep up material and contain in a refuse vessel for disposal in the same manner as for containers (see Storage and Disposal).

SAFETY DIRECTIONS

Poisonous if absorbed by skin contact or swallowed. Will irritate the eyes and skin. Avoid contact with eyes and skin. Open sachets only as needed. When opening the container, preparing spray and using the prepared spray, wear cotton overalls over normal clothing, buttoned to the neck and wrist and a washable hat and elbow-length chemical resistant gloves and face shield. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use, wash gloves and face shield and contaminated clothing.
