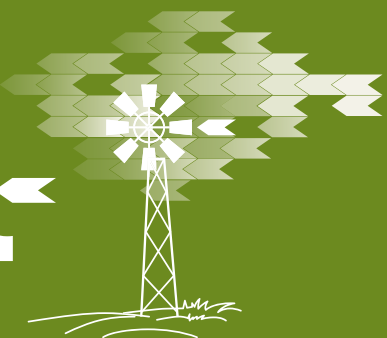

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a cool, well-ventilated area. Out of direct sunlight. Single rinse before disposal. Add rinsing to spray tank.
