GENERAL INSTRUCTIONS

Before opening, carefully read Directions for Use, Precautionary Statements, Safety Directions and First Aid Instructions. This product is a non-selective herbicide for use in certain perennial crops, around agricultural buildings, in aquatic areas, commercial and industrial areas, domestic and public service areas, forests and pastures and in agricultural areas prior to establishment of any edible or non-edible crops but not prior to transplanting tomato seedlings.

EQUIPMENT USAGE, MAINTENANCE AND CLEANING

Spray solutions of this product should be mixed, stored and applied only in stainless steel, aluminium, brass, copper, fibreglass or plastic or plastic lined containers. This product or spray solutions of this product, react with galvanised steel or unlined steel (except stainless steel) containers and tanks, to produce hydrogen gas which may form a highly combustible gas mixture. This gas mixture can flash or explode if ignited by open flame, spark, welder's torch or other ignition source. Spray tanks, pumps, lines and nozzles should be thoroughly rinsed with clean water following application to prevent extensive corrosion. Thoroughly wash aircraft, especially landing gear after each days spraying to remove herbicide residues.

PROTECTION OF CROP, NATIVE AND OTHER NON-TARGET SPECIES
Avoid contact with foliage, green stems or fruit of crops, desirable plants and trees, since severe injury or destruction may result.

DRIFT WARNING

DO NOT apply under meteorological conditions or from spraying equipment which could be expected to cause spray to drift onto nearby susceptible plants, adjacent crops, crop lands or pastures.

PROTECTION OF WILDLIFE, FISH, CRUSTACEA AND ENVIRONMENT
Do not contaminate dams, rivers or streams with the product or used container. When controlling weeds near water, refer to label directions to minimise the entry of spray into the water.

STORAGE AND DISPOSAL

Store in the closed, original container in a dry, cool, well-ventilated area. DO NOT store for prolonged period in direct sunlight.

Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point.

If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. Empty containers and product should not be burnt.
