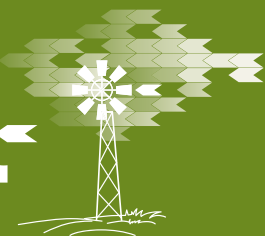

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. DO NOT store near feedstuffs, fertilisers or seed. Triple rinse containers before disposal. Add rinsings to the spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

SMALL SPILL MANAGEMENT

Wear protective equipment (See SAFETY DIRECTIONS). Apply absorbent material such as earth, sand, clay granules or cat litter to the spill. Sweep up material for disposal when absorption is completed and contain in a refuse vessel for disposal (See STORAGE AND DISPOSAL section). If necessary, wash the spill area with an alkali detergent and water and absorb the wash liquid for disposal, as above.

Additional statements required by Globally Harmonised System of Classification and Labelling of Chemicals (GHS) and Safe Work Australia: Combustible liquid. Harmful if swallowed. Very toxic to aquatic life with long lasting effects. Precautionary: Keep away from heat/sparks/open flames/hot surfaces. – No smoking. Wear protective gloves/protective clothing/eye protection/face protection. Avoid release to the environment. Wash hands thoroughly after handling. Do not eat, drink or smoke when using this product. Rinse mouth. In case of fire: Use for extinction: CO2, powder or water spray. Collect spillage. IF SWALLOWED: Call a POISON CENTER/doctor if you feel unwell. Store in a well-ventilated place.
