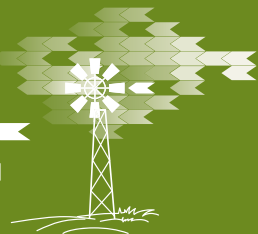

STORAGE AND DISPOSAL

This product must be stored in a locked room or place away from children, animals, food, feedstuffs, seed and fertilisers. Store in the closed, original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight.

For non-refillable containers: Triple rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

For refillable containers: Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

SAFETY DIRECTIONS

Product is harmful if inhaled or swallowed. Will irritate eyes, nose, throat and skin. Avoid inhaling spray mist. When preparing spray wear elbow-length PVC gloves and face-shield. If product in eyes, wash it out immediately with water. After use and before eating, drinking or smoking, wash hands, arms and face

thoroughly with soap and water. After each day's use wash gloves, face shield and contaminated clothing.

FIRST AID
