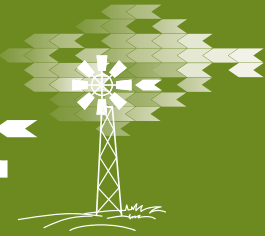

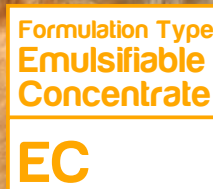

For the control of certain insect pests in various situation and for treatment of termite nests in wall cavities in accord with AS3600.2 as specified in the directions for use table.

### STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight. Triple-rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging or unused product to an approved waste management facility. If an approved waste management facility is not available, dispose of empty container or unused product in compliance with relevant local, state or territory government regulations. DO NOT burn empty containers or product.

### SAFETY DIRECTIONS

Product is poisonous if absorbed by skin contact, inhaled or swallowed. Repeated exposure may cause allergic disorders. Repeated minor exposure may have a cumulative poisoning effect. Will irritate eyes and skin. Avoid contact with eyes and skin. Do not inhale vapour or spray mist. When opening the

container, preparing the spray and using the prepared spray, wear chemical resistant clothing buttoned to the neck and wrist, a washable hat, elbow-length chemical resistant gloves, face shield or goggles, chemical resistant footwear and a half facepiece respirator with combined dust and gas cartridge. If clothing becomes contaminated with product or wet with spray, remove clothing immediately. If product on skin, immediately wash area with soap and water. If product in eyes, wash it out immediately with water. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use wash gloves, face shield or goggles, respirator (if rubber wash with detergent and warm water) and contaminated clothing.

### FIRST AID

If poisoning occurs, contact a doctor or Poisons Information Centre. Phone Australia 131126. If swallowed, do NOT induce vomiting. If swallowed, splashed on skin or in eyes, or inhaled, contact a Poisons Information Centre (Phone Australia 131126) or a doctor at once. Remove any

contaminated clothing and wash skin thoroughly. Give atropine if instructed. If in eyes, hold eyes open, flood with water for at least 15 minutes and see a doctor. Breathing vapour or spray mist is harmful and may cause an asthma-like reaction.

**WARNING** - Contains chlorpyrifos, excessive exposure to which may temporarily interfere with vision and the ability to safely operate machinery.

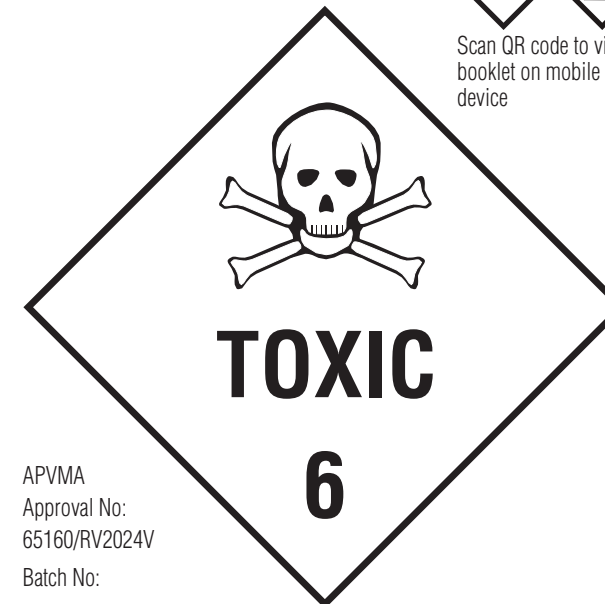
