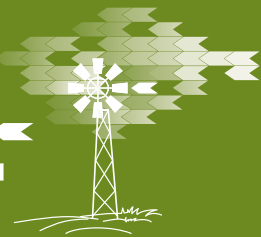

WEEDS CONTROLLED	RATE	CRITICAL COMMENTS
Annual Ryegrass, Silvergrass, Perennial grasses.	200 mL per 100 L spray solution.	For improved control of these weeds add to recommended rates of APPARENT Glyphosate 450 IPA, APPARENT Double-Down 700 WSG, APPARENT Glyphosate 510 K Salt, APPARENT Concussion 540 K Salt or equivalent products. Use in accordance with herbicide label directions.

NOT TO BE USED FOR ANY PURPOSE, OR IN ANY MANNER, CONTRARY TO THIS LABEL UNLESS AUTHORISED UNDER APPROPRIATE LEGISLATION.

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank.

DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers should not be burnt.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate streams, rivers or waterways with chemical or used containers.

SAFETY DIRECTIONS

Severely irritating to eyes. Avoid contact with eyes and skin. Do not inhale spray mist. When preparing product for use, wear elbow-length PVC gloves and face shield or goggles. After use

and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use, wash contaminated clothing, gloves and face shield or goggles.

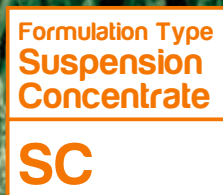
