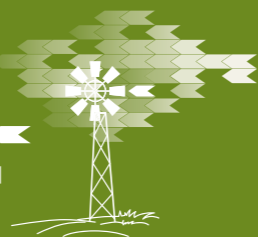

## Apparent Machete 500 HERBICIDE

### STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple-rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, puncture or shred and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

**For Refillable Containers:** Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

### SAFETY DIRECTIONS

Poisonous if swallowed. May irritate the eyes and skin. This product is alkaline. Avoid contact with the eyes and skin. DO NOT inhale spray mist. When preparing spray, wear cotton overalls buttoned to the neck and wrist and
