STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Single-rinse or shake remainder into spray tank. DO NOT dispose of undiluted chemicals on site. Puncture and deliver empty packaging to an approved waste management facility.
