## HAZARDS IDENTIFICATION

**Classified as hazardous according to criteria of Safe Work Australia.  
Not classified as a Dangerous Good according to the ADG Code.**

**SECTION 4 FIRST AID MEASURES****FIRST AID**

**Ingestion:** If swallowed do NOT induce vomiting. If poisoning occurs, contact a Doctor or Poisons Information Centre. Phone 131 126. Rinse mouth and give plenty of water to drink. Make every effort to prevent vomit from entering the lungs by careful placement of the patient.

**Eye contact:** Immediately hold eyes open and flood gently with clean water until chemical is removed. Ensure irrigation under eyelids by occasionally lifting them. Do not try to remove contact lenses unless trained. If irritation persists, seek medical advice.

**Skin contact:** Remove contaminated clothing. Wash skin with soap and water thoroughly to remove chemical. If skin is irritated, seek medical advice.

**Inhalation:** Remove to fresh air and observe until recovered. If effects persist, seek medical advice.

**Advice to Doctor:** No specific antidote. Treat symptomatically.

**SECTION 5 FIRE FIGHTING MEASURES**

**Specific Hazard:** Not flammable. There is little risk of an explosion from this product if commercial quantities are involved in a fire.

**Extinguishing media:** Not combustible, use extinguishing media suited to burning material. If waterfog or fine water spray is used, ensure all runoff is contained. Contain all runoff.

**Hazards from combustion products:** Product will decompose when burnt and will emit toxic and noxious fumes. Firefighters to wear self-contained breathing apparatus and suitable protective clothing if risk to of exposure to vapour or smoke.

**Precautions for fire-fighters and special protective equipment:** Isolate fire area. Evacuate downwind residents. Wear full protective clothing and self-contained breathing apparatus. Do not breathe smoke or vapours generated.

**SECTION 6 ACCIDENTAL RELEASE MEASURES**

**Emergency procedures:** Wear cotton overalls, buttoned to the neck and wrist (or equivalent clothing) and elbow-length PVC gloves. In the case of spillage, stop leak if safe to do so, and contain spill. Prevent spillage entering drains or watercourses. Contain and absorb spilled material with absorbent material such as sand, clay, cat litter or material such as vermiculite. Collect recoverable product for use as labelled on the product. Vacuum, shovel or pump contaminated spilled material into an approved container and dispose of waste as per the requirements of Local or State Waste Management Authorities. Keep out animals and unprotected persons. Launder protective clothing before storage or re-use.

**SECTION 6****ACCIDENTAL RELEASE MEASURES**

**Material and methods for containment and cleanup procedures:** To clean spill area, tools and equipment, wash with a solution of soap, water and acetic acid/vinegar. Follow this with a neutralisation step of washing the area with a bleach or caustic soda ash solution. Finally, wash with a strong soap and water solution. Absorb, as above, any excess liquid and add both solutions to the drums of waste already collected.

**SECTION 7****HANDLING AND STORAGE**

**Precautions for Safe Handling:** Will irritate the eyes. Avoid contact with eyes. Wash hands after use. When opening the container and preparing spray wear cotton overalls, buttoned to the neck and wrist (or equivalent clothing) and elbow-length PVC gloves. After each day's use, wash gloves and contaminated clothing.

**Conditions for Safe Storage:** Store in the closed, original container in a well ventilated area away from children, animals, food, feedstuffs, seed and fertilisers. Do not store for prolonged periods in direct sunlight. Ideally, the product should be stored below 30°C.

**SECTION 8****EXPOSURE CONTROLS / PERSONAL PROTECTION****Exposure Guidelines:**

Exposure guidelines have not been established for this product by Safe Work Australia.

**Biological Limit Values:**

**Engineering controls:**

Use in ventilated areas. Keep containers closed when not in use.

**Personal Protective Equipment (PPE):**

General: When opening the container and preparing spray wear cotton overalls, buttoned to the neck and wrist (or equivalent clothing) and elbow-length PVC gloves. After each day's use, wash gloves and contaminated clothing.

Personal Hygiene: Clean water should be available for washing in case of eye or skin contamination. Wash skin before eating, drinking or smoking. Shower at the end of the workday.

**SECTION 10****STABILITY AND REACTIVITY**

**Chemical Stability:** Product is considered stable in ambient conditions for a period of at least 2 years after manufacture.

**Conditions to avoid:** Do not store for prolonged periods in direct sunlight.

**Incompatible materials:** Strong oxidising agents and strong alkalis.

**Hazardous decomposition products:** When involved in a fire will emit toxic and noxious fumes.

**Hazardous reactions:** No particular reactions to avoid.

**SECTION 11****TOXICOLOGICAL INFORMATION**

No specific data is available for this product as no toxicity tests have been conducted on this product. Information presented is our best judgement based on similar products and/or individual components. As with all products for which limited data is available, caution must be exercised through the use of protective equipment and handling procedures to minimise exposure.

**Potential Health Effects:****ACUTE EFFECTS**

**Swallowed:** Harmful if swallowed.

**Eye:** This product will cause eye irritation. Symptoms may include stinging and reddening of eyes and watering. If exposure is brief, symptoms should disappear once exposure has ceased.

**Skin:** May cause mild irritation of the skin. LD<sub>50</sub> > 4000 mg/kg (similar product). Classified as a potential sensitiser by skin contact.

**Inhaled:** Product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort. LC<sub>50</sub> (rat) (4hr) 6.32 mg/L (similar product).

**Long Term Exposure:**

**Chronic toxicity:** No evidence has been obtained of mutagenic, carcinogenic, teretogenic, neurogenic or reproductive effects.

**SECTION 12****ECOLOGICAL INFORMATION**

**Environmental Toxicology:** Azoxystrobin is moderately toxic to fish with LC<sub>50</sub> = 1.76 mg/L for rainbow trout (96 hr) and LC<sub>50</sub> = 4.2 mg/L for Carp (96 hr). highly toxic to certain aquatic invertebrates with 48-hour LC<sub>50</sub> = 0.83 mg/L for daphnia magna. Moderately toxic to algae with EC<sub>50</sub> = 0.71 to 2.2 for green algae (72 hr). Low toxicity to earthworms with LC<sub>50</sub> > 1000 mg/kg and bees with acute oral and Contact LD<sub>50</sub> > 200 µg/bee.

**Environmental Fate:**

Azoxystrobin is stable in water and not persistent in soil. It has low to high mobility in soil and is absorbed by organic molecules. It has a medium potential for bioaccumulation.

**SECTION 13****DISPOSAL CONSIDERATIONS**

**Spills and Disposal:** Persons involved in cleanup require adequate skin protection - see Section 8. Spills and Disposal: Keep material out of streams and sewers. Dispose of drummed wastes, including decontamination solution in accordance with the requirements of Local or State Waste Management Authorities.

**Disposal of empty containers:** Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and bury empty containers in a local authority landfill. If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

**SECTION 14****TRANSPORT INFORMATION**

(Contains Azoxystrobin). Hazchem code ●3Z. Hazard Identification Number (HIN) 90.

**SECTION 15****REGULATORY INFORMATION**

Under the Standard for Uniform Scheduling of Medicines and Poisons (SUSMP), this product is a Schedule 5 poison.

This product is registered with the Australian Pesticides and Veterinary Medicines Authority. APVMA number 68733.

This product is classified as a Hazardous Substance under the criteria of Safe Work Australia. Xn: Harmful, Xi: Irritant.

This product is not classified as a Dangerous Good according to the ADG Code for packs less than 3000 litres (SP AU01) (7<sup>th</sup> Ed).
