4 First Aid Measures

Inhalation: If inhaled, remove to fresh air. Seek medical attention if breathing problems develop.

Skin Contact:

Additional toxicological information:

The Australian Acceptable Daily Intake (ADI) for bromoxynil octanoate for a human is 0.003 mg/kg/day, set for the public for daily, lifetime exposure.
