4 First Aid Measures

Inhalation:

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if breathing problems develop.

Skin Contact:

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap. Seek medical attention if symptoms occur.

Eye Contact:

In case of eye contact, rinse with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing for at least 15 minutes. Seek medical attention if symptoms occur.

Ingestion:

If swallowed, do not induce vomiting. Immediately rinse mouth with water. Give a glass of water. Never give anything by mouth to an unconscious person. Seek immediate medical attention.

Symptoms Caused by Exposure:

Inhalation: May cause mild irritation.

Skin Contact: May cause skin irritation.

Eye Contact: May cause eye irritation.

Ingestion: Harmful if swallowed. May cause irritation to mucous membranes.

Medical Attention and Special Treatment:

The active ingredient belongs to the chloronicotinyl (or neonicotinoid) chemical group. Local symptoms are not expected. Systemic symptoms may include apathy, depressed muscular tone, respiratory disturbances and trembling cramps in severe cases of poisoning.

Treatment for systemic effects: Check pulse and blood pressure frequently, as bradycardia and hypotonia are possible. Provide supportive measures for respiratory function and cardiac action. Additional therapeutic measures involve accelerated elimination of the substance from the body (gastrolavage, saline laxatives).

6 Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear approved respiratory protection, chemical resistant gloves, protective clothing and safety boots. Evacuate all non-essential personnel from affected area. Do not breathe vapours. Ensure adequate ventilation.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal. Decontaminate spill area with water and detergent.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Use only outdoors or in a well-ventilated area.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.
